This battery pack will fit any device with a Universal USB Type A, and it weighs a mere 9 ounces, to avoid overloading your firearm. Featuring a "battery-life" indicator, and made of durable, flame-retardant ABS, this battery pack is an excellent addition to any shooting system.



CHARGING THE QUICK DETACH BATTERY PACK:

The quick detach battery pack can be charged using the micro USB port. The battery can be charged using most USB type A power supplies. When charging the battery indicator light will blink. The indicators show how much charge the battery has.

- 1 Light blinking: Charging from 0-25%
- 1 Light solid, second light blinking: Charging from 25-50%
- 2 Lights solid, third light blinking: Charging from 50-75%
- 3 Lights solid, forth light blinking: Charging from 75-100%
- · 4 Lights solid: Battery fully charged

CHECKING BATTERY LEVEL:

To check the battery level press the button on top of the unit and it will display the battery level range.

- 1 Light: 0-25%
- 2 Lights: 25-50%
- 3 Lights: 50-75%
- 4 Lights: 75-100%

CHARGING A DEVICE:


To charge a device using this battery pack plug a USB cord into the larger USB type A port and the other end into the USB port on your device. The battery level indicator will turn on and then turn off after a set amount of time. If using this on a device that cannot be charged but simply is powered by the battery pack the battery level indicatory may turn on when the unit is turned on.

MOUNTING:

To mount the quick detach battery:

- Place the fixed side of the mount over the lip of the picatinny rail.
- 2. Confirm the recoil lug is aligned to a slot on the picatinny rail.
- 3. Push the opposite side of the battery pack down onto the rail until it snaps on.

(To remove, pull up on the non-fixed side until it snaps loose.)
